### Who is eligible to obtain a birth certificate?

The purchase must have a "direct interest" in the record. A direct interst is defined as a documented and verifiable financial and legal interest, or an immediate kinship.

- Individual listed on the record
- Parents of individual listed on the record (Must be listed on record)
- Grandparents (Must show proof of relationship)
- Siblings of individual listed on the record (Must show proof of relationship)
- Child or Grandchild of individual listed on the record (Must show proof of relationship)
- Current Spouse (Must show proof of relationship)
- Aunt or Uncle (Must show proof of relationship)
- Court Appointed Legal Guardian (Must provide guardianship papers with seal)
- Attorney representing person named on record (Must provide direct interest spelled out on letterhead or court documents)
- State and Federal Agencies (Must provide work ID, direct interest spelled out on letterhead, court documents, or signed authorization from client)
- Social Agency (Must provide work ID and court documents or signed authorization from client)
- Step-Parent (Must show proof of relationship)
- Genealogy (Individual named on certificate must be over 75 years old and deceased, must provide proof of death)

#### What is needed to obtain a birth certificate?

# One form of primary photo identification (Must be current and valid)

- Government issued driver's license or state ID (front and back required)
- U.S. Military ID (Front and back required) OR Veteran's ID
- School ID with proof of enrollment OR work ID with proof of employment
- U.S or Foreign Passport OR Mexico Consular ID (Green)
- Department of Corrections ID card or printout with photo

## Two forms of secondary documentation (Must be current and valid)

- Signed Social Security Card
- Voter registration card with name and current address
- Current vehicle registration with name and current address
- Military Discharge (DD214)
- Home Lease/Rental Agreement, Warranty Deed with name, address, and signature(s)
