**COMMISSIONER REPRESENTATIVE:**

They approved a 144 for the Maintenance Department to hire Travis Marshall. They signed a design contract with INDOT for Bridge 533. They signed four contracts for the Recorder's Office. They heard from Donna Schroeder about placing a Liberty Tree in the courthouse lawn. Jay Gaddis was present for Discover Connersville and commissioners approved waiving a permit fee for a permanent structure at the Oasis. Commissioners had a progress meeting today regarding the women's facility and said the opening date will probably be November now.





**ADJOURNMENT:**
